

Legacy Giving

For LGBTI people, donating a legacy to organisations like ILGA-Europe means knowing that they will leave a meaningful impact towards a better world for future generations of people just like them.

Even though we all know it will happen one day, none of us like to think about the time when we will have to say goodbye to this world. Many people put off making a will because of this, but identifying who will inherit what you leave behind, whatever it is worth, is an important, meaningful part of living.

What is legacy giving?

Your will is a powerful document. It allows you to express your wishes and the values that are important to you, such as equality for LGBTI people.

Legacy giving is simply identifying a charity or organisation in your will to leave a percentage of your estate to, or a named sum, or some other asset such as securities, bank and securities accounts, life insurance, and real estate. For many people it is a beautiful and honourable gesture to give a lasting gift to a cause that is close to their hearts.

For LGBTI people, donating a legacy to organisations like ILGA-Europe means knowing that they will leave a meaningful impact towards a better world for future generations of people just like them, because they will be supporting our work towards a fair and just society that values and treats LGBTI people equally. As many LGBTI people have grown up vulnerable, feeling on the outside, not having equal rights, their contribution towards the happiness and security of LGBTI people has great meaning.

If you want to, even after your death:

- Help guarantee that our work continues at the highest levels to bring about legal and political change for LGBTI people in every country in Europe and Central Asia.
- Help us defend at the highest levels against the negative impacts of governments who seek to scapegoat and deny LGBTI people.
- Help us provide grant aid to LGBTI organisations, either in times of emergency, or to help build an ever-stronger movement for the safety, equality and freedom of LGBTI people across Europe and Central Asia.
- Help us train LGBTI activists to be the very best they can be when working for equality in their own countries and localities.
- Help connect LGBTI activists working for positive change from all over Europe and Central Asia with each other.

- Give future generations of LGBTI people the chance to live in a world where they are valued and accepted as they are at every level of society.
